ASALC MEMBERSHIP TERMS & CONDITIONS

The following terms and conditions apply to this application for membership at the Alice Springs Aquatic & Leisure Centre. Terms and Conditions will apply until further notice. ASALC reserves the right to change terms and conditions at any point. Any changes to the terms and conditions will be notified in writing on the ASALC website – www.asalc.com.au

General:

1. Memberships are non-transferable; payment is to be made in full at the time of joining.
2. Membership cards must be presented on entering the Alice Springs Aquatic & Leisure Centre.
3. All children under the age of 14 must be accompanied by a competent adult (aged 16 years or older) at all times whilst visiting the facility.
4. I acknowledge that the facility may be unavailable from time to time for carnivals or other booking; at least 1 weeks' notice will be provided. No extensions of memberships will be provided on these occasions.
5. Membership payments are non-refundable or transferable. A 7 day cooling off period applies.
6. I hereby agree to abide by all the rules and regulations of the facility and ensure that all minors under my care will do the same.
7. I acknowledge that the facility may be closed due to safety concerns at any time. Eg. Electrical Storm Activity.
8. I agree to indemnify the City, and all its officers, agents & employees in respect of any event which may occur whilst I am present or using the services or any facilities of the centre's or pursuant to this agreement, and any event which results in any damage to property or any accident, injury or loss being suffered by or occasioned to me or any person in my care and control and hereby release the City from liability unless the injury sustained by me is as a result of City's negligence

Direct Debit:

1. Direct Debit memberships include swimming at leisure entries and also Aqua Aerobic Classes.
2. Upfront payment is required for days up to the first debit run and a joining fee (\$5.10/membership).
3. Payment rejections will incur a \$6.10 administration fee. Membership may be suspended by ASALC if rejection occurs.
4. In a 12 month period up to 90 days of suspension can be applied for any reason. Please email info@asalc.com.au

Visit Pass:

1. 10 visit passes have a 1 year expiry. No programs are included in a 10 Visit swim pass.
2. Please note 10 visit family passes count for the whole family only. It DOES NOT entitle family members to 10 pass each.

Upfront 3 or 12 Month:

1. Upfront 3 & 12 month memberships include swimming at leisure entries and also Aqua Aerobic Classes.
2. Suspension may be applied to the 3 month for medical reason (doctor's certificate required); the 12 month for medical reasons (doctor's certificate required) and/or long holidays (that are greater than 4weeks in duration). Suspensions must be applied for in writing.

SWIM READY & POOL SUPERVISION RULES

Swim Ready Policy

As per our swim ready Initiative all students must:

- Wear their coloured wristband received on entry
- Visit the toilet or be wearing an aqua nappy (infants & toddlers)
- Shower before entering the pool
- Let a lifeguard/swim instructor know where their parent is.

If you or your child has had diarrhoea or vomiting in the past 2 weeks, please do not swim.

Pool Supervision Rules

- Children 0-5 years & non swimmers; parents must be within arm's reach at all times.
- Children 6-10 years & weak swimmers; parents must maintain visual contact at all times.
- Children 11-14 years; must be checked on by a parent/guardian regularly.

ASALC PHOTOGRAPHY POLICY

To respect the privacy of all visitors any video, camera or recording equipment is not to be used in ASALC to record anyone other than the immediate friends or family of the person recording. Additionally:

- Cameras or other recording equipment are not to be used in the change rooms or underwater at any time.
- It is an offence to record video or pictures of the general public without their prior consent.
- It is an offence to post photos on social media that have general public in them who are not known to you, without their prior consent.

If Alice Springs Aquatic & Leisure Centre staff have concerns that your photography could be in breach of the above conditions, they may ask you to stop taking any photos for the remainder of your visit.
