## ASALC MEMBERSHIP TERMS & CONDITIONS

The following terms and conditions apply to this application for membership at the Alice Springs Aquatic & Leisure Centre (hereon referred to as ASALC, or the Facility). Terms and conditions apply from the date of this application. ASALC reserves the right to update these terms and conditions at any time. ### MEMBERSHIPS

#### General:

- Memberships are non-transferable – payment in full must be made at time of joining ASALC.
- Membership cards must be presented on entering the Facility.
- All minors under the age of 14 years or less must be accompanied by an able adult (person aged 16 years or older) at all times whilst visiting the Facility.
- I acknowledge that all, or parts, of the Facility may be unavailable from time to time for competitions, carnivals or club bookings, and accept that one week's notice of, and no extensions of membership, will be provided.
- Membership payments are non-refundable and non-transferable. A seven (7) day cooling-off period applies from the date of initial payment.
- I hereby agree to abide by all the rules and regulations of the Facility and will ensure that all minors in my care abide also.
- I acknowledge that the Facility may be closed due to an emergency, or for health and safety concerns, at any time and at short or no advanced notice.
- I agree to indemnify Alice Springs Town Council (ASTC) and its employees against liability in respect of any event which may occur whilst I am present or using ASALC's services or facilities, pursuant to this agreement, or during any event which results in any damage to property or any accident, injury or loss being suffered by or occasioned to me, or any person in my care and control. I hereby release ASTC from any liability, except where the injury sustained by me is as a result of ASTC's negligence.

#### Direct Debit:

- Direct Debit membership includes general access to facilities and aqua exercise classes.
- A once-only joining fee is to be paid upfront and within a minimum 14 days prior to the first fortnightly debit payment.
- Payment rejections will incur an administration fee per occurrence. Membership may be suspended by ASALC if repeated rejections occur.
- No penalty fee applies for a suspension of membership for up to 90 days within a 12 month period — please email your request to [info@asalc.com.au](mailto:info@asalc.com.au)

#### 10 Visit Pass:

- 10 Visit Passes are valid for 12 months only from the date of issue. Un-used passes will not be refunded after expiry. Classes and programs are not included.
- 10 Visit Family Passes are valid entry for a family group only and DO NOT entitle individual family members to 10 passes each.

#### Privacy Statement

#### Upfront 3 Months or 12 Months:

### SWIM READY & POOL SUPERVISION RULES

#### Swim Ready Policy

As per our Swim Ready Policy, all swim students must:

- Wear the coloured wristband received on entry
- Visit the toilet or be wearing an aqua nappy prior to entering the pool (infants and toddlers)
- Shower before entering the pool
- Show a lifeguard or swim instructor where their parent is located within the Facility.

If a guardian or child has experienced diarrhoea or vomiting within the previous two (2) week period, DO NOT SWIM.

#### Pool Supervision Rules

- Children 0-5 years and non-swimmers — a parent / guardian must be within reach AT ALL TIMES.
- Children 6-10 years and inexperienced swimmers — a parent / guardian must keep visual contact at all times.
- Children 11-16 years — a parent / guardian must regularly check on their welfare.

### PHOTOGRAPHY POLICY

ASALC respects the privacy of all visitors to the Facility. As such, visual recording devices can NOT BE USED within the Facility to record anyone other than those in your immediate family or social group. Furthermore:

- Visual recording equipment IS NOT PERMITTED AT ANY TIME within the Facility's change rooms or in its pools, under the water.
- It is an offence to record the general public without their prior consent.
- It is an offence to post recordings on the Internet containing members of the general public, who are not known to you, without their prior consent.

ASALC staff have the right to stop anyone recording within the Facility if they have concerns that the recording is in breach of these conditions. If anyone is asked repeatedly to stop recording, they may be asked to leave the Facility.
