# **Primary Objective**

Located at the Alice Springs Aquatic & Leisure Centre (ASALC) and within the Community Development Directorate the position will support general cleaning and minor maintenance activities throughout the facility. To mitigate the risk of transmission of disease or infection, clean, present and maintain ASALC facilities including toilets, change rooms, offices and grounds to a high standard for all users.

## Key Responsibilities

- Actively contribute to maintaining a safe and hygienic facility, incorporating appropriate cleaning practices, agents and chemicals in daily routine and in accordance with manufacturer specifications.
- Clean and suitably present all areas in and around the ASALC facility including the removal of litter, cleaning glass and hard floor surfaces, wiping down surfaces, dusting, emptying bins, spot cleaning, vacuuming and removal of spider webs.
- Ensure ASALC facility is a safe environment for users. Perform minor maintenance duties as required.
- Keep accurate daily work records, report safety hazards and issues including necessary repairs to the supervisor in a timely manner.
- Ensure that all open spaces and storages areas are adequately maintained and that they are kept in a clean and tidy manner.
- Perform grounds maintenance as required.
- Assist in the set-up and pack-up related to community events and swimming carnivals
  ensuring any high touch surfaces on furniture and equipment is suitably cleaned and / or
  sanitised as required.
- Uphold organisational values and behave according to Council's Code of Conduct, including treating other employees and the general public with respect.
- Maintain own health and safety and that of other people in the workplace or those who may be affected by the work being carried out.
- Perform other duties within capabilities and / or consistent with the level of this position as required.
