## Notice of Motion

**Alice Springs Town Council** 

*I, Deputy Mayor Eli Melky hereby give notice of my intention to present the following motion at the Special Ordinary Meeting of Council, scheduled for 17<sup>th</sup> May 2022.* 

#### **MOTION:**

- A. That the Alice Springs Town Council declare the level of crime and anti-social behaviour currently being experienced by our community to a State of Emergency, and request immediate action by the Northern Territory Government to deal with the following issues:
  - 1. Home invasions
  - 2. Serious assault on members of public
  - 3. Sexual assault by youth on members of public
  - 4. Car theft and abandoned cars
  - 5. Illegal use of vehicles as weapons of destruction
  - 6. Property damage
  - 7. Shop stealing
  - 8. Unroadworthy and unregistered vehicles
  - 9. Effective monitoring of CC Cameras
  - 10. Economic downturn due to safety concerns
  - 11. Harassment and intimidation by roaming gangs
- B. That the Northern Territory Government introduce an emergency 4-month curfew lockdown on children who are not under 'Responsible Family' or 'Elder Watch' and are known repeat offenders out late at night roaming the streets, as a short term measure.
- C. That the Alice Springs Town Council work with the Northern Territory Government by making available suitable Council facility to assist where children who are not under 'Responsible Family' or 'Elder Watch' can be cared for and provide triage until the responsible person can be reached.
- D. That the Northern Territory Government provide mental health support to victims of crime.
- E. That the Northern Territory Government provide financial compensation to victims of crime including businesses.
- F. That the Northern Territory Government increase support to their relevant departments who are responsible for community safety.
- G. That the Northern Territory Government apply existing legislation on education and ensure children of school age are attending school during school hours.
