

#### 3.1 Illegal dumping - Director Technical Services

The Director Technical Services welcomed Sarah Fairhead (DIPL) and Peter Vasel (NT-EPA) to the meeting for an inter-agency discussion in regard to Illegal Dumping and working towards better outcomes for the Alice Springs area.

Discussion ensued in regard to collaborative solutions with an aim to change and improve behaviours, and the development of a pilot strategy to challenge the practice of illegal dumping. This strategy, would be directed at a local level, developed in a way where the effectiveness could be measured, and would include; education in regard to appropriate behaviour, enforcement, and information for the community to advise how much local agencies are wasting on this problem.

The Committee discussed responsibilities, collaborative resources, capacity that each agency would have to contribute, and the approval process for a draft strategy once developed.

It was discussed that a pilot program may take 2-3 months to develop through a working group and would ultimately be aimed to offset the ongoing costs that all agencies incur as a result of illegal dumping.
