Residential program

- The residential program had a spike in activity during Aug-Oct, in response to communication of the end of the incentive program, with 75 new customers in August. Interest dropped off substantially after the end of August deadline with 9 new customers in Sep and Oct combined.
- Total household registrations now at 2871 and 2661 home energy surveys undertaken to date.
- It was a busy period for SHW, with total of 876 solar hot water systems now installed to date. Expecting to surpass the target of 900.

Commercial program

Commercial program new activity has been slow. Existing projects are expected
to fully expend remaining funding, with the focus now on evaluation and transition
planning.

Marketing and Community Engagement

 The "Year of Energy Champions" campaign has been progressing well, with ads appearing in the Advocate weekly.

Succession

- Succession planning is now a major area of activity, with discussions with key stakeholders and with Alice Water Smart.
- A detailed business case has been prepared to be submitted to the NT government in early November.

8. WASTE MANAGEMENT

Reinier Laan provided overviewed.

- The town kerbside collection contract has been awarded to Cleanaway from October 2012.
- The total waste collected at the landfill for the period 1st July to the 30th October 2012 was 14478.66 tonnes
- The total waste recycled for the same period was 3258.98 tonnes.
- The high recycling total is due to the total estimated concrete recycled in October 2012.
- Firebreaks was created around the landfill by Correctional service and inside the landfill fence by Council.

Wine & Spirit Glass container collections commenced at Territory Recycling centre on Monday 1st October 2012. A 10¢ refund is offered per container to residence of Alice Springs.

The following figures indicate container collection and refunds provided:-

Alice Water Smart Homes and Business has had a really busy and productive first 16 months. Key achievements to date have been:

 650 homes have had Water Efficiency Consultations, so are well on the way to meet the target of 1000 consults by mid next year. These consults have identified saving of more than 320 million litres annually, primarily by adjusting and updating irrigation systems and by fixing leaks.

- The Business project is so far working with 31 local businesses and organisations and has also identified another 300 million litres that can be saved in Alice Springs. These organisations are provided with cost benefit analysis for these changes and the majority (again irrigation and fixing leaks) have short payback periods.
- The Community Water Rules concept has been launched with a presentation by Professor Tony Wong, the Chief Executive of the CRC for Water Sensitive Cities. The first of three public workshops was well attended with 60 or so members of the community coming to express their views and the second workshop is scheduled for the 12th of November. Print, Radio and Television ads have been rolled out to inform and inspire the public to contribute to the rules.
- A Citizens Advisory Panel has been formed to help shape the Community Water Rules and will have its first meeting just prior to the second workshop



Annual Garden Report 2011-2012 Compiled by Kim Hopper (Project Officer for the ASCG) with contributions from XXX

Introduction

The Alice Springs Community Garden was originally championed by a group of individuals in 2007. Since that time the Arid Lands Environment Centre has supported the community interest in developing a community garden by auspicing the project and providing support in the form of advocacy for grant monies and by securing a lease on the community garden site at Frnace Smith Park in 2010.

In March 2011 project officers were employed by ALEC to progress the development of the community garden in accordance with the Alice Springs Community Garden Project Plan (2010).

This Annual Garden Report doubles as a project officers report and summarises the activities and progress of the community garden project since March 2011. The report addresses the operational outcomes as defined in the 2010 Project Plan with specific reference to the most recent goals and Vision as defined by the Alice Springs Community Garden Reference Group (2012).

Growing Healthy Gardens

It is important to recognise that the Alice Springs Community Garden is situated on Arrente land and is closley located to a sacerd site that holds significance to the traditional owners of this land.

The aspiration of the garden has been to develop a site of education and resource that enhance the resilience and connectedness of the local community. One of the key approaches to developing a garden site that can provide for the communities needs was to imbed permaculture principles in the design and operation of the community garden. In 2009 Jen Clarsen (landscape architect) was engaged to develop the original design of the garden. The design has since evolved to reflect water harvesting earthworks that were undertaken in 2011 and new inputs from the local community and permaculture designers.

Learning Together

continue to grow.

The ASCG aims to bring together people from all walks of life and to create an environment where the community is learning and sharing together. The events associated with setting up the community garden from consultations to informal working bees to structured workshops have been forums for sharing of ideas, knowledge and specilised skills. Now that there are plots established at the garden we can safely assume that this precious space for shared learning will

Valuing safe Friendly Environments

The community garden aspires to be an inclusive, best-practice, relaxing, abundant environment amoung other things.

The garden is achieving this through promotion and presence in the community and by designing the garden activities to be reflective of these goals.

The garden has adopted a No smoking, no drugs, no alochol policy that ensures the space is recognised as one that supports healthy activities that are safe for families and the broader the community.

The garden is working with special needs groups to ensure the site suits their needs and has hosted a variety of workshops for these groups to ensure they can receive full advantage of being involved in the community garden project (see 'Network' for more detail)

The community garden hosted a Harmony Day event in March 2011 which attracted XX people representing more than XX cultural groups. This coming together of people represents a great strength for the garden and has reflected the need in the community for space and activities that appeal to the diversity of cultures in our community.

It has also been important to incorporate art and diverse expression into the garden and this has been achieved by encouraging individual expression and

actively seeking funding for Arts related projects. The 'Gateway to Sustainabilty' project which included a sculptural archway and artwork on the fence is one example of a public arts proposal that received developmental funding. It is due for submission in early 2013.

Creating Useful resources

It is a goal of the community garden to increase community resilience by increasing local food production and associated skills through education and the provision of useful resources.

In October 2011 the community garden was awarded a \$46000 grant from the lan Potter foundation to setup the community garden as an educational 'living classroom' site. This was istrumental in getting the garden site established and connecting the community to the project. The grant monies were used to implement a series of workshops and events that established the infratsructure and garden facilties (see workshops/events below). These activities provided educational opprtunites for the community and intiated a resource base for the garden. The Ian Potter grant assisted the garden in attracting other in-kind support from the community. The workshop program engaged 70 participants with many of these returning for working bees and garden events. From these workshops the garden has compiled educational resources that are available to the community online and have been drawn apon to develop infrastructure by our members and Network gardens.

Inspiring effective leadership

A goal of the community garden is to operate with a sustainable funding and management model and provide opportunities to incubate social enterprise. It has been apparent that since the infrastructure of the garden has been established many ideas of management and enterprise opportunities have naturally arised.

To affectively support the development of the garden it has been important to establish a governance model that is representative of the communities focus, abilties and needs.

There has been a consistent contribution in the gardens management by the local community that has taken various forms over the past 18 months. In 2011 there was an 'interim structure' that reflecte dthe new component of the garden 'Network' and the employment of community garden project officers. In 2012/13 the garden hopes to move to a more formal committee that will manage

affairs of the garden in the absence of these project officers with support of the local community and ALEC.

In March 2011 the community gardens reference group championed and ran two 9 Spaces Visioning sessions to help establish the identity and direction of the garden leadership. These sessions were invaluable in creating a framework of aspirations and a vision for the garden to work towards.

Our fantastic volunteers and community garden reference group raised the profile of the gardens significantly in the past 18 months and contributed to raising over \$10k for the development of the garden.

Recently the community garden reference group have developed a User Guide to help induct new plot holders to the garden and a draft constitution to aid in the transferance of the garden to an incorporated organisation should this occur towards the first term of the lease expiring (2015).

Membership Model

Currently the ASCG operates under ALEC membership. This membership system is currently being refined and trialed to best suit the business systems of ALEC and the functionality of the community gardens administration. Currently any memebr of ALEC is considered a member of the community garden and is entitled to the benefits including access to workshops, online forums, enewsletters, and XX
